- blended delivery allows courses to include some online (real time) training delivery provided that no more than 30% of total tutor contact time is delivered online via in person, synchronous, live methods. The rest of the course must be delivered face-to-face
- for the face-to-face parts of the course, participants are required to attend physically in person and in the training room in real time
- for the online parts of the course, participants are required to attend in person the live, synchronous online delivery
- participants must meet the COSCA attendance requirement for each of the above delivery methods
- up to 30% of supervised counselling practice sessions on practice placements can be delivered remotely
- courses which allow participants to deliver counselling remotely as part of the counselling practice placement are required to train participants in remote counselling and/or signpost them to relevant training courses
- COSCA Accredited and Approved trainers whose participants can work remotely with clients during counselling practice placements are required to evidence that they are competent to train participants in working remotely as counsellors.
