INSURANCE FOR COUNSELLORS AND PSYCHOTHERAPISTS INFORMATION LEAFLET

By joining COSCA as a counsellor/psychotherapist you are agreeing to abide by its Statement of Ethics and Code of Practice and to submit to its disciplinary procedures.

Problems which can give rise to a claim against you are difficult to predict but they can come from conflicts between the counsellor/psychotherapist on the one hand and clients, colleagues, employers, professional bodies, training organisations and the law on the other. It is, therefore, important to have professional indemnity cover that is independent of your professional body.

Professional indemnity insurance, which is independent of COSCA, provides you with insurance cover for public liability and claims for professional negligence.

Depending on the insurer, with your cover or in addition to it, you can receive advice on any matter connected with your practice. Your insurer can also assist:

- in defending proceedings where a question of professional principle is involved
- in vindicating a member's professional interest, honour and character
- in proceedings brought by a client arising from the act or omission of the member
- when damages are awarded by a court or a settlement is made out of court

Because any problem can potentially lead to a complaint or even legal proceedings insurers do require you to let them know of these situations. As the outcome of any proceedings could affect your practice and reputation it is strongly recommended you contact your insurers immediately to seek the appropriate advice and/or representation.
